PRODUCT SPECIFICATIONS

DIRECTIONS:

Material Preparation: Mix thoroughly before using. GuideLine GXR will generally require no alteration prior to spray application. See application section.

Surface Preparation: Surfaces should be dry, clean and free of oil, grease, dust, and other foreign matter.

Application: May be sprayed through machines that are specifically designed to spray traffic paint. If rolling or brushing is necessary, GXR may need water added to slow dry time. Recommended film thickness is 15 mils. wet.

Warning: Do not apply on new asphalt when surface temperatures exceed 115°F. This could cause severe cracking or peeling of the asphalt. If application is absolutely necessary under these conditions, thoroughly mix water (maximum 12-oz. per five gallon pail) to GXR and apply a test stripe in an inconspicuous area. Let set for minimum of ½ hour and inspect for cracking along stripe's edge. If cracking appears, await cooler temperatures before application. Caution: Surface temperatures may vary from section to section. Applying less mils. can also further reduce cracking.

GLASS BEADS:

Glass beads should be applied by any suitable method which can be regulated to dispense six pounds of glass beads per gallon of paint. When applying glass beads to a rolled or brushed line or legend, glass beads must be applied at the same time the marking is applied.

CAUTION:

Do not apply acrylic water reducible traffic paints when temperature is below 50°F or humidity is above 80%. Do not apply if rain is expected within 4 hours.

EQUIPMENT CLEAN UP:

100% Durable Acrylic Cleanup of utensils and machinery can be best accomplished by using warm soapy water.

Do not use organic solvents.

WARNING: Traffic paint reduces pavement texture and may cause the surface to become more slippery. Caution must be exercised, particularly when paint is used on walking surfaces such as ramps, crosswalks, and areas where slip resistance is a major safety factor. Slip resistance can be improved with the application of fine aggregate (sand) onto the wet paint.
